THIS MEMORANDUM OF UNDERSTANDING (MOU) IS MADE this

College of Teacher Education (Autonomous & ISO Certified) an institution of higher learning established under the Andhra Mahila Sabha, founded by Dr, Durgabai Deshmukh and whose office is at Durgabai Deshmukh Vidyapeetham, O.U Campus, Hyderabad-500007.

(Hereinafter referred to as "CTE" or the first party, whose expression shall where the context so permits include its successors-in-title and permitted assigns of the other part.

AND

Pallavi Educom Management Services Limited, whose office is at post Box no.1582. 7th Floor, Minerva Complex, S.D. Road, Secunderabad-500003(hereinafter referred to as PE viSL) whose expression shall where the context so permits include its successors in-title and permitted assigns of the second party.

CTE and PEMSL shall hereafter be collectively referred to as "both parties" and reference to "party" shall mean CTE or PEMSL, as the case may be.

PART I

A 3- month self finance certificate course in ECCE has been offered by CTE as on Add-on course since 2015. CTE & PEMSL agreed to enter into this MOU for the above course, from the academic year 2022-'23.

WHEREAS both parties enter into this MOU to collaborate efforts to establish and develop academic exchange and co-operation in teaching, training, research and development in areas as follows:

- A1 The salient features and terms and conditions of implementing the course are given in PART II of this MOU;
- A.2. To design and implement other short term courses in teacher training in the identified areas. The salient features and terms and conditions of implementing such courses will be governed by suitably modified Part II of this MQU;
- B. To promote exchange of information, resource materials, publication, etc of mutual interests;
- C. To promote and facilitate the exchange of research, teaching staff and students;
- D. To organize national/international conferences, in the field of education; and
- E. To foster co-operation in relevant areas of education of mutual interest.

Both parties mutually agree to the following:

1. IMPLEMENTATION

Both parties shall implement part- II of this MOU which contains details of the activity, responsibilities of each party, financial aspects, time schedules and all such items.

2. FINANCIAL ARRANGEMENTS

All expenses shall be borne by both the parties

3. CONFIDENTIALITY

- 3.1 Both Parties agree to observe confidentiality from others not concerned or connected with this MOU.
- 3.2 For purposes of this MOU, "confidential information" includes all technical know-how, financial information and other commercially valuable information.
- 3.3 PEMSL is not free to enter into similar MOU for this 3- month Certificate course in ECCE with any other institution.

4. COMMENCEMENT AND DURATION

- This MOU shall commence on the date of its signing and shall remain in effect for a period of 5 (five) years, subject to an annual review at which both Parties shall by mutual agreement determine the terms and conditions of extensions, modifications or duration of this MOU.
- 4.2 This MOU may be terminated prior to the expiry date between both Parties subject to at least 3 (three) months prior written notice without detriment to the ongoing programs initiated under this MOU.
- 4.3 Any dispute arising out of the interpretation or implementation of this MOU shall be settled amicably between both the parties

PART II

- 1. The three-month certificate course in Early Childhood Care and Education (ECCE) shall be offered in self-financing mode by the CTE AMS either in collaboration with Pallavi Edu com Management Services Limited (PEMSL) or any educational institute interested in collaborating with the CTE AMS
- 2. Both the parties shall identify the course coordinators, one from each organisation.
- 3. Both Men & women with Senior school certificate/ Intermediate (10+2) or equivalent are eligible to apply without age limit.
- 4. The Minimum intake is 20, for viability of the course. Any shortfall shall be underwritten by the second party (PEMSL)
- 5. The medium of instruction shall be English
- The course may be offered in hybrid mode (offline and online) twice in an academic year preferably in January and July.
- 7. The course shall be taught by those having a PG degree in any subject from any recognized university/Institute and PG Diploma in ECE or B.Ed
- 8. Admissions shall be made by the first party. Preparation of promotional material and advertising shall be undertaken jointly by both the parties.
- 9. Individual modules will be delivered by either of the parties, as given below:
